NOTIFICATION

No. CK/Home Br./(Vehicle Accessories)/2025-058: WHEREAS, the Deputy Inspector General of Police, Traffic, Karachi, vide letter No. DIGP/Traffic/RDR/(4146-A)/5587-89/Karachi, dated 20.10.2025, has requested for the imposition of ban under Section 144 of the Cr.P.C. on the sale, distribution, and installation of illegal accessories (including tinted windows, unauthorized green number plates, pressure horns, revolving lights, hooters, flashlights, and sirens), within the local limits of Karachi Division, in order to prevent impersonation and criminal activities enabled by such illegal modifications.

AND WHEREAS, there are sufficient grounds to proceed under section 144 Cr.PC to prevent the sale, distribution, and installation of illegal vehicle accessories, therefore, it is necessary that all persons shall be barred from doing above actions.

NOW THEREFORE, in exercise of powers under section 144 (6) Cr. P.C, delegated by the Home Department, Government of Sindh under Notification No. SOJI/8-01(03)/2016, dated 21.05.2020, I, Syed Hassan Naqvi, Commissioner Karachi Division, do hereby impose complete ban on the sale, distribution, and installation of illegal vehicle accessories (including tinted windows, unauthorized green number plates, pressure horns, revolving lights, hooters, flashlights, and sirens), within the local limits of Karachi Division, for a period of 02 months w.e.f. 29.10.2025 to 28.12.2025, with immediate effect.

In pursuance of Section 195 (i) (a) Cr.PC, the Station House Officers (SHOs) of concerned Police Stations are hereby authorized to register complaints under Section 188 PPC in writing against the violation of Section 144 Cr.PC.
