## **NOTIFICATION**

No. CK/Home Br./(Heavy Traffic)/2025-60: In continuation of this office Notification No. CK/Home Br./(Heavy Traffic)/2025-054, dated 17.10.2025, and in pursuance of the request of the Deputy Inspector General of Police, Traffic, Karachi, vide letter No. DIGP/Traffic/RDR/(562 J.A)/4521-28/Karachi, dated 25.08.2025, and the report of the Secretary RTA, shared vide letter No.RTA/2025/58 dated 11.09.2025, a complete ban under section 144 Cr.PC is imposed on the movement of heavy traffic on Jinnah Avenue, from Super Highway (M-9 Karachi-Hyderabad Motorway) near Saima Pari Classic and Rufi Global City upto Malir Halt, Shahrah-e-Faisal, purely in the public interest and for better traffic management.

- Furthermore, an alternate route, i.e., Link Road (Eastern Bypass) from Kathore, 02. Super Highway (M-9) up to Sassi Toll Plaza, National Highway (N-5), shall remain available to ensure the hassle-free movement of heavy goods vehicles during the permitted hours.
- These amendments shall remain in force for a period consistent with the validity period of 03. the previous notification No. CK/Home Br./(Heavy Traffic)/2025-054, dated 17.10.2025, within the local limits of Karachi Division.
