No. CK/Home Br./(Unfrequented Routes)/2026- 04 : In continuation of this office Notification No. CK/Home Br./(Unfrequented Routes)/2026-63, dated 19.12.2026 and on the request of Pakistan Rangers Sindh vide letter No. 0151/GS(Ops)/467, dated 12.02.2026, **I, Syed Hassan Naqvi, Commissioner Karachi Division**, in exercise of powers under section 144 (6) Cr.PC delegated by Home Department, Government of Sindh under Notification No. SOJI/8-01(03)/2016, dated 21-05-2020, do hereby impose complete ban / closure of the following 08 unfrequented routes under section 144 Cr.PC in order to secure Karachi and to curb the possible movement of miscreants **for a period of 02 months w.e.f. 20.02.2026 to 20.04.2026** within the local limits of Karachi Division:
