**NOTIFICATION**

**No. CK/Home Br./(MCR)/2026-05: WHEREAS**, the Deputy Inspector General of Police, Traffic, Karachi vide letter No. DIGP/Traffic/RDR/(2451)/770-72/Karachi dated 17.02.2026, has requested for the imposition of a ban under section 144 Cr.PC on the movement of 1+2 and 1+4 Motor Cab Rickshaws on the following designated main arteries of Karachi to reduce traffic hazard and inconvenience to the general public:

**AND WHEREAS**, in order to prevent traffic hazards and ensure the smooth flow of traffic within the city, there are sufficient grounds to proceed under section 144 Cr.PC on the request made by the Traffic Police, Karachi.

**NOW THEREFORE**, in exercise of powers under section 144 (6) Cr. P.C, delegated by the Home Department, Government of Sindh under Notification No. SOJI/8-01(03)/2016, dated 21.05.2020, **I, Syed Hassan Naqvi, Commissioner Karachi Division**, do hereby impose complete ban on the plying of 1+2 and 1+4 Motor Cab Rickshaws on the aforementioned roads within the territorial limits of Karachi Division, for a period of 02 months **w.e.f. 23.02.2026 to 23.04.2026**, with immediate effect.

In pursuance of Section 195 (i) (a) Cr.PC, the Station House Officers (SHOs) of concerned Police Stations are hereby authorized to register complaints under Section 188 PPC in writing against the violation of Section 144 Cr.PC.
