## **NOTIFICATION**

**No. CK/Home Br./(AIOU-Exams)/2026-08**: WHEREAS, the Assistant Commissioner (Revenue), for Deputy Commissioner, District Korangi, Karachi, vide letter No. AC(R)/D.K/981/2026 dated 19.02.2026, has forwarded a copy of letter No. F.1-3/Conduct/Aut-25/3648 dated 10.02.2026, received from the Controller of Examinations, Allama Iqbal Open University (Department of Examinations), Islamabad, wherein it has been informed that the University is conducting the Final Examinations for Semester Autumn-2025, scheduled to be held from 02.03.2026 to 11.05.2026, within the jurisdiction of District Korangi, Karachi. The management of AIOU has, therefore, requested for the imposition of a ban under Section 144 Cr.PC to ensure the peaceful conduct of the examinations.

**AND WHEREAS**, in order to conduct examination in smooth, transparent, fair and peaceful manner and to maintain sanctity of examination premises during the examination, it is expedient to take necessary measures.

**NOW THEREFORE**, in exercise of powers under section 144 (6) CrPC delegated by Home Department, Government of Sindh under Notification No. SOJI/8-01(03)/2016, dated 21-05-2020, I, **Syed Hassan Naqvi, Commissioner Karachi Division**, do hereby declare the premises of Examination Centers as restricted areas for the general public except candidates bearing valid Admit Card as well as the staff on duty and prohibiting any type of gathering within a radius of two hundred yards of the examination centers including operation of photocopiers, display of weapons, and use of cell phones or other electronic devices for adopting any unfair means during the examination days / hours for a period **w.e.f. 10.03.2026 to 11.05.2026**, with immediate effect.

In pursuance of Section 195 (i) (a) Cr.PC, the Station House Officers (SHOs) of concerned Police Stations are hereby authorized to register the complaints under Section 188 PPC in writing for the violation of Section 144 Cr.PC.
