**NOTIFICATION**

**No. CK/Home Br./(Exams)/2026- //** : **WHEREAS**, the Controller (Test Administration), Federal Board of Intermediate and Secondary Education, Islamabad vide letter No. FBI/TA/N&A/2026/461, dated 02.03.2026, has informed that SSC 1<sup>st</sup> Annual Examination – 2026, under the Federal Board of Intermediate and Secondary Education is to commence from 31.03.2026 (from 02:30 PM to 05:30 PM) throughout Pakistan and abroad. In order to deal with interlopers and intruders in close proximity to the examination centres, and to provide a congenial atmosphere for the supervisory staff as well as the examinees, the FBI&SE has requested for imposition of ban under section 144 Cr.PC prohibiting any type of gathering within a radius of two hundred yards of the examination centres, during the examination days/hours.

**AND WHEREAS**, in order to conduct examination in smooth, transparent, fair and peaceful manner and to maintain sanctity of examination premises during the examination, it is expedient to take necessary measures.

**NOW THEREFORE**, in exercise of powers under section 144 (6) CrPC delegated by Home Department, Government of Sindh under Notification No. SOJI/8-01(03)/2016, dated 21-05-2020, **I, Syed Hassan Naqvi, Commissioner Karachi Division**, do hereby declare the premises of Examination Centers as restricted areas for the general public except candidates bearing valid Admit Card as well as the staff on duty and prohibiting any type of gathering within a radius of two hundred yards of the examination centres including operation of photocopiers, display of weapons, and use of cell phones or other electronic devices for adopting any unfair means during the examination days / hours for a period **w.e.f. 13.04.2026 to 04.05.2026**, with immediate effect.

In pursuance of Section 195 (i) (a) Cr.PC, the Station House Officers (SHOs) of concerned Police Stations are hereby authorized to register the complaints under Section 188 PPC in writing for the violation of Section 144 Cr.PC.


