NOTIFICATION

No. CK/Home Br./Cattle Mandi/2026-338 : WHEREAS, the Municipal Commissioner, KMC, Town Municipal Corporations (TMCs), and other agencies have proposed the establishment of cattle mandis at various locations across the city on the eve of Eid-ul-Azha 2026 for the facilitation of citizens in purchasing sacrificial animals.

AND WHEREAS, the Deputy Commissioners of Karachi Division have furnished their recommendations regarding the proposed locations of cattle mandis, and in pursuance of the decisions taken in the meetings held on 16.04.2026 and 27.04.2026 at the Commissioner Office, Karachi, the following cattle markets are hereby permitted to be established on the occasion of Eid-ul-Azha 2026:

The organizer of Cattle Markets / Mandis agrees to strictly adhere to the following SOPs, which include measures to ensure:

- No obstruction to traffic flow in the vicinity of the cattle mandis.
- Maintenance of hygienic conditions within the premises, including proper waste management and disposal.
- Implementation of adequate security measures to prevent unauthorized access and ensure the safety of animals, staff, and visitors.
- Prevention of nuisance in the surrounding area, including noise pollution, odor, and other disturbances.

- v. The organizer shall ensure the immediate removal of animal waste and other debris from the premises to prevent the accumulation of waste and maintain cleanliness.
- vi. Proper disposal methods shall be employed in accordance with applicable regulations and guidelines.
- vii. The organizer shall establish designated parking areas for vehicles belonging to cattle traders, buyers, and visitors which shall be clearly marked and organized to optimize space utilization and minimize congestion.
- viii. The organizer shall implement and maintain all above mentioned measures throughout the operation of the cattle mandi.

AND WHEREAS, in order to avoid traffic congestion, unhygienic conditions, security issues and to prevent nuisance in the city, it is imperative to impose ban under section 144 Cr. PC on setting up of illegal Cattle Markets except at the above locations.

NOW THEREFORE, in exercise of powers under section 144 (6) Cr. P.C. delegated by the Home Department, Government of Sindh under Notification No. SOJI/8-01(03)/2016, dated 21-05-2020, **I, Syed Hassan Naqvi, Commissioner Karachi Division**, do hereby impose complete ban on the establishment of illegal cattle markets, as well as on the sale of animals outside the designated cattle markets, except at the above-specified locations within the territorial limits of Karachi Division, for the period from the date of issuance of this notification until Eid-ul-Azha 2026, with immediate effect.

In pursuance of Section 195 (i) (a) Cr.PC, the Station House Officers (SHOs) of concerned Police Stations are hereby authorized to register the complaints under Section 188 PPC in writing for the violation of Section 144 Cr.PC.
