**NOTIFICATION**

**No. CK/Home Br./(SSWMB-Offal)/2025- 17** : **WHEREAS**, the Managing Director, Sindh Solid Waste Management Board (SSWMB), Karachi, vide letter No. MD/SSWMB/2026/209, dated 04.05.2026, has informed that the contractor firms engaged by SSWMB have raised concerns regarding illegal offal tearing activities being carried out by scavengers during Eid-ul-Azha operations. Similar issues were also observed in previous years, whereby special sanitation arrangements were adversely affected due to scavengers tearing animal offal to extract tripe and mesentery, and subsequently disposing of the waste improperly across various areas of Karachi Division. This practice results in scattered animal waste, which not only creates serious public health and hygiene concerns but also poses environmental hazards and increases the risk of disease outbreaks in the locality. The Managing Director SSWMB has requested that a ban under section 144 Cr.PC may kindly be imposed on the said illegal activity for a period of five (05) days, i.e., from 27.05.2026 to 31.05.2026, within the local limits of Karachi Division, in the larger public interest, to curb the practice of illegal tearing of offals by scavengers for extraction of tripe and mesentery.

**AND WHEREAS**, considering the gravity of the situation and in the interest of the general public, there are sufficient grounds to proceed under Section 144 of the CrPC to prevent the aforementioned illegal activities.

**NOW THEREFORE**, in exercise of powers under section 144 (6) Cr. P.C, delegated by the Home Department, Government of Sindh under Notification No. SOJI/8-01(03)/2016, dated 21.05.2020, **I, Syed Hassan Naqvi, Commissioner Karachi Division**, do hereby impose complete ban on illegal offal tearing activities by the scavengers to get the tripe and mesentery during the eve of Eid-ul-Azha-2026 within the local limits of Karachi Division for a period of **five (05) days, i.e., from 27.05.2026 to 31.05.2026**.

In pursuance of Section 195(1)(a) of the Cr.P.C., the Station House Officers (SHOs) of the concerned Police Stations are hereby authorized, either on their own motion or upon a complaint lodged by the concerned Assistant Director, SSWMB, to register complaints in writing under Section 188 PPC against any person found violating the orders issued under Section 144 Cr.P.C.
