**NOTIFICATION**

**No. CK/Home Br./(SSWMB)/2026-19:** the Deputy Director (Admin), Sindh Solid Waste Management Board (SSWMB), Karachi vide letter No. DD/Admn/Misc:/SSWMB/2026/550, dated 25.05.2026, has informed that the matter of illegal collection, littering, throwing garbage and dumping debris by garbage collectors, waste pickers, scavengers, recyclers, or any individual/person in and around all nullahs and drain of Karachi and other open spaces still persists, creating a nuisance for the general public. The Board has requested the imposition of a ban under Section 144 Cr.P.C. on these activities for a period of two (02) months in the interest of public safety.

Furthermore, the Honourable High Court, in C.P. No. D-8534 of 2017, vide order dated 04.03.2026, directed the Commissioner, Karachi to ensure that no garbage is burned along the Malir River and that no solid waste is dumped in close proximity to the river.

**AND WHEREAS,** the prevailing situation warrants immediate action, and there are sufficient grounds to proceed under Section 144 Cr.P.C. to protect the environment and public life.

**NOW THEREFORE,** in exercise of powers under section 144 (6) Cr. P.C, delegated by the Home Department, Government of Sindh under Notification No. SOJI/8-01(03)/2016, dated 21.05.2020, **I, Syed Hassan Naqvi, Commissioner Karachi Division,** do hereby impose complete ban on littering, throwing of garbage, solid waste, dumping of debris, and other materials into the Nullahs/rivers of Karachi Division or the burning of garbage by waste pickers, scavengers, recyclers, or any individual/person, for a period for a period of **02 months w.e.f. 25.05.2026 to 24.07.2026,** with immediate effect.

In pursuance of Section 195(1)(a) of the Cr.P.C., the Station House Officers (SHOs) of the concerned Police Stations are hereby authorized, either on their own motion or upon a complaint lodged by the concerned Assistant Director, SSWMB, to register complaints in writing under Section 188 PPC against any person found violating the orders issued under Section 144 Cr.P.C.
