ROUTE OF PROCESSION:

Jamshed Road, Gurumandir, Soldier Bazaar, Nishter Park, M.A Jinnah Road, Saeed Manzil, Bolton Market, Bombay Bazar, Kharadar, Hussainian Iranian.

TERMS & CONDITIONS:-

1. Availability of premises with permission (if necessary) from the land owning agency/ authority.
2. Use of Public Address System in low tone. Loud Speaker ordinance should be followed strictly.
3. No Sectarian / Objectionable activities / Speeches shall be allowed, which may cause or create hatred amongst the various sects or injured feelings of the people.
4. No speaker will deliver any speech against the ideology of Pakistan
5. No sectarian/objectable branding shall be allowed to be displayed.
6. No obstruction and disturbance shall be caused to the public and traffic.
7. There shall be no display of arms or carrying of arms during the procession / Majalis.
8. Organizer will detail sufficient number of males and females volunteers at Entry Gates/Stage and Pandal for physical search/checking of the participants etc.
9. Video recording shall be made from starting to the termination of the Majalis / Procession. The Organizer will be responsible to submit the Video Cassette next day to the concerned District Administrations and Senior Superintendents of Police for record / analyzing.
10. Parking lots shall be established at-least 200 yds away from the main venue and volunteer shall be detailed.

11. Organizer will be held responsible for any mishap, harm or damage caused to any person(s) or property during the above-mentioned events.
12. That the organizer shall abide by the orders of the concerned officers of law enforcing agencies & other civic agencies.
13. Organizer shall personally be responsible for ensuring that timings are strictly adhered to and that situation remains normal.
14. No objectionable remarks will be used in Khutba / Namaz (in any language) which might outrage the feelings of other sect.
15. Organizer shall ensure strict compliance of the code of conduct issued by the Home Department, Government of Sindh and Federal Government authorities.
16. The organizer shall be held responsible for the violation of terms and condition of this permission and in case of any mishap, will face the legal consequences.
17. This license is subject to the provision of Article 121 of Police Act, 2019.
