### **NOTIFICATION**

**No. CK/Home Br./(Heavy-Traffic)/2026-20** : WHEREAS, the Deputy Inspector General of Police, Traffic, Karachi, vide letter No. DIGP/Traffic/RDR/(562/Ext.)/2806-15/Karachi dated 12.06.2026, has requested for the imposition/extension of a ban under Section 144 Cr.PC on the movement of heavy traffic vehicles during daytime hours in city areas, as well as a complete ban on the plying of heavy traffic on Jinnah Avenue from Super Highway (M-9) up to Malir Halt, Shahrah-e-Faisal, in order to mitigate traffic congestion caused by the influx of heavy vehicular traffic and to prevent road traffic accidents (RTAs).

**AND WHEREAS**, in the interest of protecting human lives and ensuring the smooth flow of traffic, there is sufficient grounds to proceed under section 144 Cr.P.C., to regulate the movement of heavy traffic within the city limits.

**NOW THEREFORE**, in exercise powers under section 144 (6) Cr. P.C delegated by Home Department, Government of Sindh under Notification No. SOJI/8-01(03)/2016, dated 21-05-2020, I, **Syed Hassan Naqvi, Commissioner Karachi Division**, do hereby impose the following restrictions:

- i. A complete ban on the movement of dumpers carrying construction materials in all parts of the city except during **10:00 PM to 06:00 AM**.
- ii. A complete ban on the movement of heavy traffic inside the city limits, excluding vehicles carrying essential commodities (water, edible oil, liquid oxygen, liquid nitrogen, medical gases categorized as lifesaving drugs, meat, skin, and other related items), except during **10:00 PM to 06:00 AM**.
- iii. A complete ban on the movement of heavy traffic on Jinnah Avenue, from Super Highway (M-9 Karachi-Hyderabad Motorway) near Saima Pari Classic and Ruffi Global City up to Malir Halt, Shahrah-e-Faisal.
- iv. Following three routes will be available for the movement of heavy traffic excluding dumpers carrying construction material:

- v. Moreover, the movement of dumpers equipped with approved tracking devices (trackers), whose access data has been integrated with the Karachi Traffic Police monitoring system, is exempted from the restriction timings within the Industrial Zones of Karachi.

These restrictions shall remain in effect for a period of two months from **24.06.2026 to 23.08.2026**, within the territorial limits of Karachi Division.

In pursuance of Section 195 (i) (a) Cr.PC, the concerned Station House Officers (SHOs) on their own and on the complaint of Section Officers Traffic (SOs) are hereby authorized to register the complaints under Section 188 PPC in writing for the violation of Section 144 Cr.PC against the violators of this Notification.

In pursuance of Section 195(1)(a) Cr.P.C., the Station House Officers (SHOs) of the concerned police stations are hereby authorized to register complaints in writing under Section 188 PPC, in cases of violation of Section 144 Cr.P.C.
