**REVISED NOTIFICATION**

In continuation of the Notification No. CK/AC(HQ)/731/2024 dated 20.11.2024, and in exercise of powers conferred under Section 7 of the Sindh Essential Commodities Price Control and Prevention of profiteering and Hoarding Act, 2005 (Amended in 2008 and 2023), I, SYED HASSAN NAQVI, Commissioner Karachi Division / Controller General of Prices and Supplies (CGPS), Karachi, hereby notify the prices of grocery items within the local limits of Karachi Division.

It is hereby clarified that, due to a clerical error in the earlier notification, the retail price of *Moong (Washed)-I* was inadvertently mentioned as 400, instead of 325. This notification supersedes the previous one and shall take effect immediately, and remain in force until further orders.
